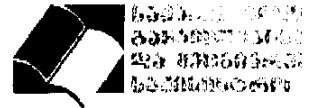
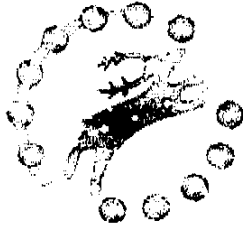

Submitted prequalification documentation and tender proposals will be opened on 25th June, 2008, 18:00 pm, at the address: Deer Leap Foundation, 68 Uznadze st, Tbilisi, 0102, Georgia, 3rd floor,

room #14.

Late prequalification documentation and tender proposals will not be considered by the tender committee.

Prequalification documentation should include following notes and information:

- a) Record from the entrepreneurs register and certified copy of the charter;
- b) Note that their property is not arrested (note should be issued by the National Agency of Public register);
- c) Note that no bankruptcy or rehabilitation proceedings are commenced against them (note should be issued by court);
- d) Note, certifying that they are not being reorganized (note should be issued by the tax department) .
- e) Tender proposal should include: Name of the bidder, legal address, contact information, bank requisites, name of the head of the organization.
- f) Note about budgetary obligations (note should be issued by the tax department).

-Note: Foreign legal and physical persons should submit Prequalification documentation from the respective agencies of relevant country, with the notarially certified translation in the Georgian language.

Legal and physical person will not pass the prequalification selection unless she/he fails to submit above listed documents in the terms determined and if one of the documents turns out to be false.

Interested persons can be acquainted with tender documentation in the organization conducting procurement before submitting prequalification documentation and tender proposals.

Bank guarantee of the fulfilment of tender conditions will be used in the tender at the value of 1% of the total cost of tender proposal, bank guarantee mechanism will be used as well to ensure fulfilment of agreement about state purchase.
